The permit for the construction and operation of the landfill with a total capacity of 3.5 million cubic meters was granted in March 2019. The landfill was opened upon completion of the first section in spring 2021.

At the same site, the company extracts raw materials such as gravel, sand and macadam and produces recycled building material for sale.

Other activities of the Davids family business are existing in the sectors of renewable energies and in the ownership and operation of leisure, sports, gastronomy service facilities and other commercial properties.
